

The Belgian Federal Government adopted in 2015 a range of measures which will deeply impact the life of companies such as index jump, wage freeze, reductions in social contributions,... Hugues Thibaut will detail those measures and he will focus on the incentives foreign companies can benefit when hiring in Belgium. He will also explain to Slovenian companies the formalities and legal requirements to be observed when posting workers to Belgium.

Group S is a single point of contact for the creation of enterprises, a social fund for self-employed and an accredited external payroll office. It has 900 employees and 30 offices in Belgium and one in Paris. Group S handles 500.000 pay slips per month and has 80.000 clients. Hugues Thibaut is Head of Group S International Department. He advices foreign companies on how to assess and optimize their salary costs when hiring in Belgium (social contribution



reductions, fringe benefits,...). He also deals with employees' mobility matters such as posting of workers, salary splits and expat regime,...

Hugues Thibaut has been EU affairs adviser for 7 years and then HR Manager of a Brussels based International association for 2 years. He graduated in European Law from the University of Louvain (Belgium). He also studied in Uppsala (Sweden) and in Tilburg (The Netherlands) and graduated in Management from the Brussels Business school.
